- **Toleration Nation?**

Is tolerance today a “myth,” an ideal beyond our grasp? Tolerance at one time in our history meant the sympathy for or indulgence of beliefs or practices differing from or conflicting with one's own. Simply put, it meant that you could disagree without being disagreeable. Unfortunately, that is no longer the case.

Historically, the cry for tolerance has often been employed by cultural “outsiders” vying for broader societal acceptance. The radical homosexual agenda is a powerful recent example. Employing a tolerance mantra and armed with sophisticated media, cultural and legal strategies, the drivers of this agenda have in a mere span of 15 years successfully moved from a position of relative weakness to becoming perhaps the dominating force of the American cultural landscape. ● **You Might be a Redneck, um, I mean, Right Wing Extremist!**

Did you vote “yes” on Proposition 8? Are you pro-life? Do you support 2nd Amendment rights? Are you concerned about our economic future? Do you think secure borders are a good idea? Are you a veteran returning from Afghanistan or Iraq? Do you believe Bible prophecy about the end times? If you answered “yes” to one or more of these questions, you just might be a red neck and a “right wing extremist” according to an April 7, 2009 report released by the Obama administration’s U.S. Department of Homeland Security (DHS).

The bizarre DHS report acknowledges that the government has “no specific information that domestic right wing *terrorists* are planning acts of violence” (emphasis added). Yet that doesn’t stop the government from using sweepingly overbroad language and implying that otherwise model American citizens who simply disagree with one or more tenants of Obama’s left wing political agenda might also be a right wing extremist and therefore prone to violence. The wildly speculative innuendo and illogic displayed throughout the report is both staggering and ominous. ● **WCLP Encourages Student Participation in the Day of Truth.**

This Monday April 20, 2009, serious Christian middle and high school students all over the country will participate in The Day of Truth. Sponsored and promoted by a coalition of pro-family policy and legal organizations, the Day of Truth was launched in 2005 to

ensure the free speech rights of Christian students to present an opposing viewpoint to those organizations that promote homosexuality in the public schools. The catalyst for the creation of the Day of Truth was the need for a student-led, Christ-centered response to the GLSEN (The Gay, Lesbian, Straight Education Network) sponsored "Day of Silence." GLSEN's Day of Silence encourages students to remain silent throughout the entire school day as part of their agenda to promote the practice of homosexuality and indoctrinate students to accept homosexual behavior. Legitimate concerns have been raised that this approach may disrupt classroom instruction and waste taxpayer dollars.

Monday's Day of Truth provides students with an opportunity to counter the promotion of the homosexual agenda in public schools and express an opposing viewpoint from a Christian perspective. Participating students are encouraged to wear T-shirts and pass out cards (outside of class time) with the following message:

I'm speaking the Truth to break the silence.

True tolerance means that people with differing -- even opposing -- viewpoints can freely exchange ideas and respectfully listen to each other.

It's time for an honest conversation about homosexuality.

There's freedom to change if you want to.

Let's talk.

In our experience, we have often observed that, in the marketplace of ideas, God's Truth will prevail. In light of that fact, the WCLP is encouraging students to become informed and participate in the Day of Truth. Students should speak the Truth in love by having an honest conversation about homosexuality while at the same time publicly exercising their constitutional right to free speech during non-instructional time.
